DOMESTIC TRAVEL



UNITED STATES

- CDC advises that fully vaccinated people can travel with the U.S.

- U.S. will require a Negative COVID-19 test for **entry** beginning Jan. 26, 2021. For more information – [Click here](#)
- Passengers must complete a disclosure and attestation form before departure to the U.S.

- Passenger's arriving into Los Angeles County from out of state and over the age of 16, must complete this online form. All non-essential travelers entering LA County who are not fully vaccinated must follow quarantine rules [LA County form](#)
- Unvaccinated travelers visiting Hawaii will require testing and must fill out a mandatory Health form

- Passengers traveling to Rhode Island will need to complete a Certificate of Compliance Form and Out of State Travel Screening Form. Those arriving from states with a positive test rate of 5% or higher must quarantine for 10 days or provide proof of a negative Covid-19 test taken within 72 hours of arrival. Fully vaccinated travelers do not need to quarantine if it has been 14 days since your final shot.

- Domestic travelers who aren't fully vaccinated will need to provide the negative results of a COVID-19 test administered no more than 72 hours prior to entering Washington D.C.

INTERNATIONAL TRAVEL



AUSTRALIA

- Passengers are not allowed to enter Australia. Some exceptions apply.
- Those allowed to enter will be required to produce a negative COVID-19 PCR test certificate issued within the last 72 hours before arrival. If Passengers are not able to test before arrival, they will be required to be tested within 48 hours after arrival and must undergo self-quarantine until test results are available.
- Passengers are subject to testing and a 14 days quarantine at a designation location. Passengers allowed to enter must request an exemption before departure at <https://immi.homeaffairs.gov.au/help-support/departmental-forms/online-forms/covid19-enquiry-form>.
- Passengers transiting through Australia for 8 – 72 hours are subject to quarantine until their departing flight.

BELGIUM

- Passengers are not allowed to enter. Some exceptions apply
- Any transiting passenger must have evidence of onward travel and valid identification/proof of residence.
- A completed Passenger Locator Form must be submitted at most 48 hours before arrival.

BRAZIL

- Passengers must have a medical certificate with a negative Covid-19 RT-PCR test result. Must be taken no more than 72 hours prior to flight. Passengers must complete a health declaration form found [here](#) – prior to arrival [Health declaration form](#)
- Flights from the U.K., India and South Africa have been suspended
- Passengers who have been in or transited through the U.K., India or South Africa are not permitted to enter
- All airports are open, click below for more detail

CANADA

- The Canadian government extended cross-border travel restrictions with the U.S. until July 21, 2021, unless traveling for essential reasons. Foreign travelers travelling for a non-essential reason are barred from entering. If a traveler does not have an essential reason to travel, they may be denied entry.
- Effective 7 January 2021, all travellers (five years of age or older) are required to present a negative COVID-19 PCR test certificate to the airline prior to boarding a flight to Canada. The test must be performed using a COVID-19 molecular polymerase chain reaction (or PCR) test and must be taken within 72 hours prior to the traveller's scheduled departure to Canada.
- Passenger must provide basic contact information
- Foreign nationals must prove they are exempt from travel restriction, are traveling for an essential reason, and are not presenting signs or symptoms of Covid-19.
- Passengers must arrive at Calgary, Montreal, Toronto-Pearson, and Vancouver airports must undergo compulsory temperature checks before entering departure security screening
- Passengers are subject to quarantine for 14 days

CHINA

- Travelers will need a valid visa to enter China
- All travelers will be screened and subject to 14 day quarantine. The quarantine location could be a government-selected facility or hotel at the traveler's expense
- U.S. citizens are required to install location tracking applications on their phones to access different public places and businesses
- Passengers arriving PEK require testing and are subject to 14 day quarantine.
- As of September 7, travelers must provide a negative COVID-19 test certification taken no more than 3 days prior to arrival

FRANCE

- Passengers with a Covid-19 vaccination certificate and accompanying children under age 18 are permitted to enter
- Passengers must complete a declaration on honor to state that they do not have symptoms of Covid-19
- Passengers entering or transiting through France must present a completed International Travel Certificate upon arrival. [click here for more detail](#)

- Passengers from the U.S. are not allowed to enter Finland until July 25, 2021 – Exceptions apply.

GERMANY

- Germany now allows unrestricted entry for residents of the U.S.
- Travelers with a travel history to a high risk area in the 10 days prior to arrival, are required to quarantine for 10 days. Travelers from risk areas not considered high will be allowed to end quarantine subject to testing negative after arrival. Proof of vaccination or recovery from COVID-19 can be presented in lieu of a negative test certificate and exempt travelers from quarantine upon arrival.

INDIA

- Entry is allowed into India, tourism is permitted. Exceptions apply
- The Indian Government has introduced new arrival guidelines for all International travelers arriving in India. The details can be found here - [click here for details](#)
- Passengers allowed to arrive are subject to medical screening and must present a completed Self-reporting form which can be obtained at - [click here for form](#)

ITALY

- Requirements for entry into Italy are complex and very detailed. [click here for detailed information](#)

- Passengers allowed to enter are subject to self-quarantine for 14 days

JAPAN

- Passengers coming from the US (plus other countries) are not allowed to enter, exceptions apply
- Passengers transiting through Tokyo (NRT) must transit on the same day
- Travelers are subject to 14 day quarantine
- Passengers must complete a Quarantine Questionnaire - [click here](#)

KOREA (REPUBLIC OF)

- Travelers from 112 countries that concluded a visa-waiver agreement with the Republic of Korea may apply for an Electronic Travel Authorization (K-ETA). Detail can be found here - [click here for details](#)
- Travelers transiting through South Korea will be screened on arrival for symptoms

NETHERLANDS

- If you are travelling from a non-EU country where the risk of contracting COVID-19 is low ("a safe country") you may travel to the Netherlands. [Click here for a list of safe countries](#)
- Arrivals from "safe countries" are not required to present a negative test result
- A completed health declaration form must be presented prior to boarding - [click here](#)

PORTUGAL

- Passengers from the U.S. are allowed to enter beginning July 11, 2021
- Travelers must present proof of a negative Covid-19 test conducted in the last 72 hours
- A completed electronic Passenger Locator Card (PLCe) must be presented upon boarding - [click here for form](#)

SPAIN

- Passengers with a Covid-19 vaccination certificate stating that they were fully vaccinated at least 14 day prior to arrival, are allowed to enter without testing
- Unvaccinated travelers will need a negative Covid-19 or antigen test taken at most 48 hours before arrival, or a Covid-19 recovery certificate issued at least 11 days after the positive Covid-19 test result. The sample must have been taken no more than 180 days before arrival.
- Passengers must complete an "FCS Health Control Form" - [click here for form](#)

TAIWAN

- Foreign nationals without a resident certificate are not allowed to enter Taiwan for social visits or tourism.
- Passengers are NOT allowed to transit through Taiwan
- Passengers transiting or entering Taipei must have a medical certificate with a Covid-19 RT-PCR test result issued no more than 72 hours prior to entry - [more detail](#)
- Passengers are subject to testing and quarantine
- Passengers traveling on business must be able to prove their business travel purpose: passengers with a "special entry permit for Covid-19 outbreak" visa

UNITED KINGDOM

- All persons (including UK nationals and residents) arriving in the UK from outside the common travel area must provide proof of a negative COVID-19 test taken within 3 days of departure to the UK. For more information [Click here](#)
- Passengers who have visited or transited through certain countries are not allowed to enter – click for information
- Passengers are subject to self-quarantine for 10-days. For Details - [click here](#)
- A completed “Public Health Passenger Locator Form” must be presented to immigration upon arrival.
